- (1) Development cost up to \$150,000 based on Rawlinson's Construction Cost guide as amended.
- (2) Development Cost between \$150,000 and \$2,000,000 submit cost summary report (copy to be obtained from Council).
- (3) Development cost in excess of \$2,000,000 submit Registered Quantity Surveyors detailed Cost Report (Copy to be obtained from Council).
- If 2 or more fees are applicable to a single development application (such as to subdivide land & erect a building on one or more lots created by the subdivision), the maximum fee payable for the development is the sum of those fees.

Tipping Fees

Applicable to Kempsey Waste Management Centre, Bellbrook, South West Rocks & Stuarts Point Transfer Stations.

Waste Transfer Station Fees can be charged at the Waste Management Centre if the weighbridge fails.

Kempsey Waste Management Centre, South West Rocks and Stuarts Point Transfer Stations do not accept cash.

Kempsey Waste Management Centre hours of operation is 7am to 4:30pm Monday to Friday and 9am to 4pm Saturday and Sunday, including Public Holidays (excludes Christmas Day), unless otherwise advised.

Kempsey Waste Management Centre landill operational hours from Monday to Friday are 7:30am to 3:30pm and Saturday is 9am to 2:30pm (landfill tipping face), to allow for daily cover activities as per EPA landfill requirements. The landfill tipping face is closed on Sundays.

Kempsey Waste Management Centre asbestos bookings require 24 hours notice, and all asbestos disposal is strictly between 8am to 3pm. Asbestos bookings maybe cancelled by Kempsey Waste Management Centre staff due to unsafe or wet weather conditions for safe unload activities.

Transfer Stations do not accept commercial waste, industrial waste, or construction and demolition waste. All commercial, industrial, construction and demolition waste loads must be delivered to the Kempsey Waste Management Centre.

Bellbrook, South West Rocks & Stuarts Point Waste Transfer Stations do not operate on Public Holidays.

Definition of Materials:

Sorted Waste: Waste sorting is the process by which waste is separated into different recoverable materials. The aim of waste sorting is to help the community save money and save our landfill airspace which helps the environment (reduced charges apply)

Unsorted Waste: Waste that was not sorted or separated which contains recoverable recycling materials or fail to deposit each type of source-separated waste materials (higher charges apply)

A. Event Applications on Land Owned, Managed or Controlled by Council

Events fall into two categories and all applicants are required to lodge an Application Form and pay the appropriate fees as outlined below:

- a. **Major Events** include, but not limited to, occasional or one-off events such as food & beverage markets, carnivals, amusement rides, fireworks, helicopter flights, concerts and parades.
- b. Minor Events include, but not limited to, occasional or one-off events such as filming or drone flights, weddings, busking, fitness groups or bootcamps and commercial sporting events.

Note 1: Not for profit organisations are included in the Event Application process and are required to lodge an Application Form and pay the appropriate fees for their event. Not for profit or community organisations may request an exemption from the hire fees by making application 6 weeks prior to the event.

Note 2: Regular markets require Development Approval and are not included in this category.

Note 3: Some events or commercial activities may require a Crown Lands licence or a Native Title Assessment, which may attract an additional fee.
